Governments have spent decades building physical border control infrastructure. But today's biggest security risks don't begin at the checkpoint - they're global, dynamic, and increasingly upstream. Checks used to be done at the point of arrival; now, they can be done earlier in the journey, before a traveler even reaches the border.

With international air travel projected to exceed 2.4 billion travelers by 2040, and with rising numbers of border crossings by land and sea, manual checks and legacy systems can't keep pace. These inspections don't scale and don't prevent threats before arrival. In fact, relying on in-person checks and paper-based processes creates blind spots and loopholes that sophisticated actors are exploiting.

Border officers are in danger of becoming overworked and overwhelmed. Governments need more information, and of better quality, to protect their nations, but this is causing friction in the journey.

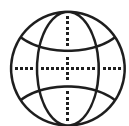

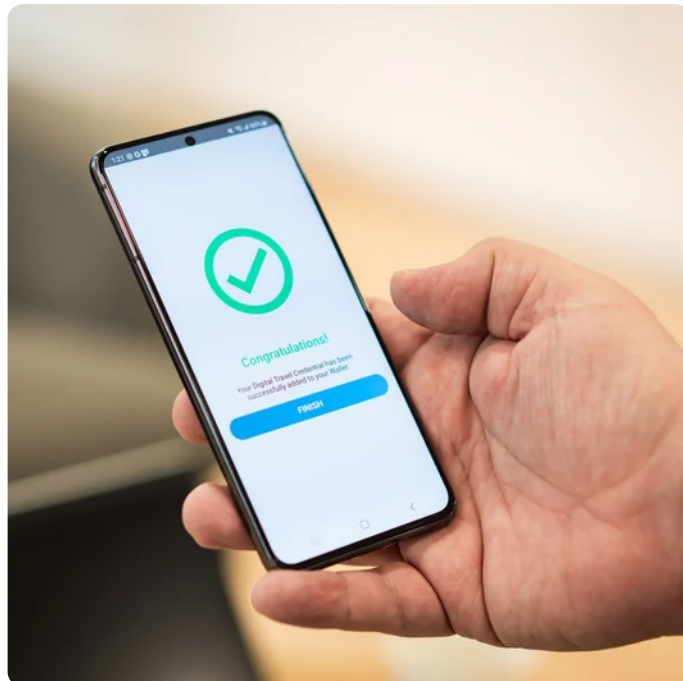
Case Study: Happy One Pass in Aruba

In partnership with SITA, the Government of Aruba launched Happy One Pass – a pilot where travelers created a DTC on their mobile and were authenticated biometrically at the border crossing, replacing manual processing.

The outcome?

- Border crossing in as little as 6 seconds
- Streamlined customs clearance
- Reduced pressure on border officers
- Faster processing for eligible travelers
- Stronger control without physical document handling
- Potential for rollout across hotels, car rentals and for tour bookings

This is how governments can shift from reaction to prevention – without adding boots at the border.
